## MINUTES OF REGULAR MEETING OF THE BOARD OF DIRECTORS OF THE EL PASO LEADERSHIP ACADEMY

**First Item of Business – Call to Order and Quorum.** The Chairman called the meeting to order at 5:38 pm, and it was determined that a quorum, consisting of the majority of directors of the Company, was present and ready for the transaction of business. The following directors were present:

**Second Item of Business – Approval of Minutes.** Approval of the Board's Minutes from the November 15, 2017 Regular Meeting was considered. Scott Adkins made a motion to approve the Minutes and Kirk Pavia seconded the motion. Following a vote by the Board, the Minutes from the aforementioned meeting were approved unanimously.

**Third Item of Business – Vote on New Board Member**. Scott Adkins moved and Allan Lindstrom seconded a motion to approve Joe Sanchez as a member of the EPLA Board. The motion was approved unanimously.

Fourth Item of Business - EPLA Parent Forum. No parents were in attendance.
